## WELCOME Jordan Shead

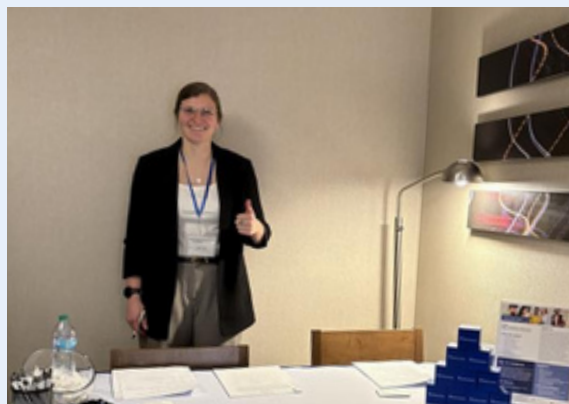
